This position is critical to the continued success of CDFA's education, advocacy, research, resources and networking efforts. This position is located in Columbus, OH. The starting salary is \$35,000 - \$45,000 per year depending on experience and qualifications. Other benefits include flexible working hours, travel opportunities and compensation time.

Duties:

The *Manager, State Programs Outreach* is responsible for CDFA's activities to build strong state relationships and programming in the southern region of the United States. This includes managing the Council's State Roundtables, a specialized initiative aimed at building strong state and local networks of stakeholders through education, research, reporting, engagement and technical assistance. The *Manager, State Programs Outreach* will be responsible for working with fellow CDFA team members to build these networks and execute events, conduct meetings, manage event logistics, publish newsletters, manage web content, recruit speakers, organize advisory committees and other tasks.

In addition to these primary responsibilities, the *Manager, State Programs Outreach* will also assist with:

- Managing state roundtables in the southern region (FL, TX, GA, SC, VA, others),
- Executing state events from start to finish including selecting conference venues, coordinating with venues on the logistics of each conference and serving as onsite contact at each event,
- Working with coalitions, partnerships and other groups to strengthen state outreach capacity,
- Recruiting speakers and panelists for live conferences and webcasts,
- Assisting with the development of publications and electronic newsletters,
- Assisting with the execution of educational events and conferences,
- Managing various advisory committees for state activities,
- Providing leadership at events on behalf of the Council,
- And other duties and special projects as assigned by the President & CEO.

Considerable travel is expected with 5-7 trips annually. All expenses are paid for travel and compensatory time is provided for excessive travel demands.

Qualification:

Qualified candidates must possess multi-disciplinary skills and the ability to build and execute complex initiatives. A bachelor's degree is required. Knowledge of or experience in economic development,

public finance, city planning, urban affairs or related subject areas is preferred but not required. Candidates should be familiar with project and event management and be able to balance multiple tasks at once. Candidates should have excellent organizational skills and be familiar with Microsoft Office, working on the Internet and using email routinely. CDFA is seeking a people person who is motivated to succeed and help build the organization.

The ideal candidate must possess the ability to work independently, with strong interpersonal skills, and a high energy level. The ability to work under deadlines and successfully handle multiple priorities and excellent relationship-building skills is a must. Possessing great communication skills including listening and providing feedback is required. Finally, candidates should be able to work in a team environment and be willing to contribute to all of the Council's initiatives.
