This position is critical to the continued success of CDFA's advancement and sponsorship efforts. This is an exciting opportunity for an energetic and enthusiastic person to contribute to a great organization, working to create economic prosperity across the country.

This position is located in Columbus, OH. The starting salary is \$30K per year depending on experience and qualifications. The benefits package includes twelve days paid vacation and ten days sick leave, a monthly health insurance stipend, flexible working hours and an annual simple plan IRA contribution. Travel is not expected for this position, but may be offered occasionally.

Duties:

The Development Administrator is responsible for management of CDFA's extensive internal database systems, sponsorship support and general office management. This includes:

- Managing CDFA's contact database system including processing updates, importing new contact lists, and managing email subscriptions.
- Assisting with coordination and fulfillment of CDFA sponsor benefits.
- Overseeing CDFA's general office management including answering office main line, completing supply orders, and processing receipts and other paperwork.
- Providing staff assistance to the CDFA President & CEO.
- Other duties and special projects as assigned by the Director of Development.

Qualifications:

Qualified candidates should be familiar with customer service and outreach. Candidates should have excellent organizational skills and be familiar with Microsoft Office, working on the internet and using email routinely. CDFA is seeking a people person who is motivated, has strong interpersonal and relationship-building skills, and a high energy level. The ideal candidate should be able to work independently, meet deadlines and successfully handle multiple priorities. Great communications skills over the phone and email are highly desired. Finally, candidates should be able to work in a team environment and be willing to contribute to all of the Council's causes. A bachelor or associates degree is preferred and high school degree is required.
