JOB DUTIES

Reporting to Managing Director, Redevelopment. Senior Project Manager is able to perform most duties with a high level of independence and requires minimal supervision.

Primary responsibility for the following activities:

- Manage a team of professionals responsible for process and program implementation in the City's ten (10) tax allocation districts
- Coordinate activities associated with tax allocation bond issuance
- Administration of all tax allocation district applications.
- Maintenance of all tax allocation district accounts.
- Creation of financial projections for all tax allocation districts.
- Creation of the regular update reports for all tax allocation district stakeholders.
- Communication with City of Atlanta departments, attorneys, financial advisors, consultants and all tax allocation district stakeholders on a regular basis.

Specific activities of the Senior Project Manager include:

- Manage all personnel responsible for TAD activity. Engage and manage the activities of a team of professional third-party consultants.
- Develop, implement and sustain an effective and efficient application and selection process for tax allocation district projects, including a fair, thorough and rigorous due diligence process.
- Develop and sustain strategies to maximize quality development, tax base growth and job creation within the districts. Ensure the effective use of public funds in TAD-financed projects.
- Work with the City's Finance Department to, assure effective processes and controls for project monitoring, disbursement of funds and reimbursement of direct and indirect administrative costs.
- Oversee implementation of TAD Strategic Plan recommendations and ensure compliance with goals of the economic development strategy.
- Provide oversight of Atlanta BeltLine Inc. activities as it relates to the BeltLine TAD.
- Manage community engagement processes.
- Market, solicit and oversee the implementation of specific development projects within tax allocation districts.
- Manage outstanding Tax Allocation Bonds to ensure optimal performance of the district and provide cost savings to the City.
- Developing RFPs for specific projects within tax allocation districts that are consistent with the economic development strategy or other City priorities.
- Lead communication with the business, real estate, and builder communities to provide information about tax allocation district incentives and to understand the current market within tax allocation districts.
- Lead negotiations with developers and other applicants for tax allocation district funds.
- Coordinate the creation and maintenance of department infrastructure, including implementation of documented 'best practice' policies and procedures.
- Monitor developer and project compliance with terms and conditions.

- Monitor development project operating and financial performance.
- Preparation of marketing and other informational materials.
- Effectively represent organization at various public and private events.
- Communicate effectively and disseminate information to bondholders and investors.
- Plan and implement various economic development-related activities and initiatives on behalf of Invest Atlanta as needed.
