


#### CUMULATIVE CALIFORNIA PUBLIC DEBT ISSUANCE (IN BILLIONS)



#### CALIFORNIA PUBLIC DEBT ISSUANCE, JANUARY (IN MILLIONS)




### STATE\* VERSUS LOCAL DEBT ISSUANCE, JANUARY (IN MILLIONS)



# DODD-FRANK REFORM ACT

### CALENDAR OF EVENTS

Below are current MSRB or SEC events and activities related to the implementation of the Dodd-Frank Wall Street Reform and Consumer Protection Act.<sup>1</sup>

### UPDATES TO JANUARY

**29-31** MSRB Board of Directors held a quarterly meeting in Atlanta, GA.

### UPDATES TO FEBRUARY

- 5 The SEC adopted an interim final rule to extend exemptions under the Securities Act of 1933, Securities Act of 1934, and Trust Indenture Act of 1939 for security-based swaps that were defined as "securities" prior to July 11, 2011. The interim final rule extends the exemptions to February 11, 2017.
- 7 The SEC final rule for the Removal of Certain References to Credit Ratings Under the Investment Company Act becomes effective. The compliance date is July 7, 2014.

### MARCH

3 Comments were due to the SEC on the interim final rule adopted by the SEC, Board of Governors of the Federal Reserve System, the Federal Deposit Insurance Corporation, and the U.S. Department of the Treasury Office of the Comptroller of Currency. The interim final rule is a companion to the final Volcker rule and will permit banking agencies to retain investments in pooled funds that invested their proceeds primarily in securities issued by community banking organizations grandfathered in under the Dodd-Frank Act. The interim final rule becomes effective April 1, 2014.

- 10 Comments due on MSRB proposed rule G-42, Duties of Non-Solicitor Municipal Advisors.
- 24 Comments due to the SEC on the proposed Amendments for Small and Additional Issues Exemptions under Section 3(b) of the Securities Act rule.
- Amendments to MSRB Rule G-8 (Books and Records to be Made by Brokers, Dealers and Municipal Securities Dealers), MSRB Rule G-11 (Primary Offering Practices), and MSRB Rule G-32 (Disclosures in Connection with Primary Offerings) become effective.




#### **TIMELINESS OF SUBMITTAL OF REPORTS**

### REPORTS OF PROPOSED DEBT ISSUANCE (RPDIs)\* RECEIVED JANUARY 2014



\* California Government Code Section 8855(h)(3) states that RPDIs must be submitted no later than 30 days prior to issuance.

### REPORTS OF FINAL SALE (RFSs)\* RECEIVED JANUARY 2014



\* California Government Code Section 8855(j) states that RFSs must be submitted within 45 days of the signing of the bond purchase contract (negotiated or private financing) or the acceptance of a bid (competitive offering).

### **OUTSTANDING 2013 ISSUES**

Issuers are required to notify the California Debt and Investment Advisory Commission (CDIAC) no later than 30 days prior to the sale of any debt issue. No later than 45 days after the issuance of the debt, issuers are then required to submit a report of final sale to CDIAC. To assist issuers in complying with the statute and to ensure consistency in the data reported, CDIAC has developed two reports, the Report of Proposed Debt Issuance (RPDI) and the Report of Final Sale (RFS).

Each year CDIAC audits both reports to ensure that we have received a RFS for each RPDI that has been submitted. In reviewing RPDIs received in calendar year 2013, CDIAC found that it had not received RFSs for 74 proposed issues. For the majority of these outstanding issues, the RFS is more than

55 days overdue based on the original proposed sale date (Figure 1).

Issuers, or their representatives, should have received an Outstanding Issue Letter (OIL) in January 2014 requesting the status of these issues. CDIAC sent out a second OIL at the end of February. In response to these OILs issuers are required to submit a notice of cancellation, an updated sale date, or a RFS prior to March 15, 2014, as appropriate. If CDIAC does not receive one of these notices, it will void the RPDI received and require the issuer to submit a new RPDI.

### OUTSTANDING MARKS-ROOS AND MELLO-ROOS FISCAL STATUS REPORTS

The Mello-Roos Act requires all issuers of Mello-Roos bonds after January 1, 1993 to annually submit Yearly Fis-

cal Status Reports (YFSRs) to CDIAC no later than October 30.<sup>3</sup> YFSRs covering the reporting period of July 1, 2012 through June 30, 2013 (FY 2012-13), were due to CDIAC no

later than October 30, 2013. YFSR reporting is required until the bonds are no longer outstanding. According to CDIAC's data, 1,379 Mello-Roos YFSRs should have been submitted.

As of February 2014, 99 percent of the Mello-YFSRs have been received (1365 of the 1379 expected reports). CDIAC staff is contacting the issuers or their designated representatives to request the remaining 14 YFSRs.

In accordance with the Marks-Roos Local Bond Pooling Act issuers of Mark-Roos bonds after January 1, 1996 must also annually submit YF-SRs to CDIAC no later than October 30th.4 YFSRs for FY 2012-13 were due to CDIAC no later than October 30, 2013. Issuers of Marks-Roos debt must also report each year until the bonds are no longer outstanding. As of February, only 81 percent of the expected Marks-Roos YFSRs have been received. CDIAC developed three reports to facilitate Marks-Roos YFSR reporting: 1) a report for finance authority issuers, 2) a report for local obligors (LOB) - local agencies whose bonds were purchased using the proceeds of the finance authority bond issue, and 3) the loan report - loans to local agencies made by the finance authority from proceeds of the authority's bond issue. Figure 2 shows the number of reports expected versus those received.

All of CDIACs reporting forms may be submitted electronically using our web-based reports. OUTSTANDING ISSUES, CALENDAR YEAR 2013




### Marks-Roos Issuer Compliance With AB 2300 Reporting Requirements

Under Chapter 723, Statutes of 2001 (AB 2300, Florez), issuers of debt authorized under the Marks-Roos Local Bond Pooling Act of 1985 are required, with some exceptions, to submit copies of public hearing notices and resolutions of intent to issue debt for capital improvement projects to the California Debt and Investment Advisory Commission (CDIAC) and the State Attorney General's Office (AG) (see text box for background information on AB 2300). The requirement has been in effect since January 1, 2001. In 2013, CDIAC received 101 Reports of Final Sale for Marks-Roos bond issues.1 Based on a review of each of these issues, staff determined that each of the issues met the filing exemptions provided under Government Code 6586.5 and 6586.7 and, therefore, were not required to submit public hearing notices or resolutions of intent to CDIAC or the AG.

Table 1 and Table 2 summarize the results of CDIAC's review of the 101 capital improvement bond issuances.

Issuers can complete the Reports of Proposed Debt Issuance and Final Sale for Marks-Roos bonds online at CDIAC's website at <a href="https://www.treasurer.ca.gov/cdiac/reporting.asp">www.treasurer.ca.gov/cdiac/reporting.asp</a>. Unless exempted, issuers must submit public hearing notices and copies of resolutions of intent to issue debt in accordance with AB 2300

CDIAC will continue to track compliance with this statute and report on its findings in future issues of *Debt Line*.

Some issuers may have not yet reported the proposed or final sale of bonds to CDIAC, although they are required by law to do so 30 days prior to the sale and within 45 days following the sale.

### **EXCERPTS FROM GOVERNMENT CODE SECTIONS 6586.5 AND 6586.7**

HEARING NOTICE EXEMPTION. Under various subsections of Government Code Section 6586.5, local agencies are exempt from filing copies of a hearing notice with CDIAC and the State Attorney General's Office if the bonds are issued:

- Pursuant to the California Community Development Law, Part 1 (commencing with Section 33000) of Division 24 of the California Health and Safety Code;
- To finance transportation facilities and vehicles;
- To finance a facility that is located within the boundaries of an authority, provided that the authority that issues those bonds consists of any of the following:
  - Local agencies with overlapping boundaries;
  - A county and a local agency or local agencies located entirely within that county;
  - A city and a local agency or local agencies located entirely within that city;
- To finance a facility for which an authority has received an allocation from the California Debt Limit Allocation Committee; and
- Of an authority that consists of no less than 100 local agencies and the agreement that established that authority requires the governing body of the local agency that is a member of the

authority in whose jurisdiction the facility will be located to approve the facility and the issuance of the bonds.

In addition, as stated in subdivision (c) of Section 6586.5, bonds issued for any of the following purposes are also exempt from the reporting obligations:

- To finance the undergrounding of utility and communication lines;
- To finance, consistent with the provisions of this chapter, facilities for the generation or transmission of electrical energy for public or private uses and all rights, properties, and improvements necessary therefor, including fuel and water facilities and resources;
- To finance facilities for the production, storage, transmission, or treatment of water, recycled water, or wastewater;
- To finance public school facilities; and
- To finance public highways located within the jurisdiction of an authority that is authorized to exercise the powers specified in Chapter 5 (commencing with Section 31100) of Division 17 of the Streets and Highways Code, provided that the authority conducts the noticed public hearing and makes the finding of significant public benefit in accordance with this section.

RESOLUTION OF INTENT EXEMPTION. Government Code 6586.7 exempts local agencies from filing resolutions of intent to issue bonds under Article 1 of the Marks-Roos Act as well as those issued for the following purposes:

- Specified in subdivision (c) of Section 6586.5;
- Pursuant to the California Community Development Law, Part 1 (commencing with Section 33000) of Division 24 of the California Health and Safety Code;
- To finance transportation facilities and vehicles;
- To finance a facility that is located within the boundaries of an authority, provided that the authority that issues those bonds consists of any of the following:
  - Local agencies with overlapping boundaries;
  - A county and a local agency or local agencies located entirely within that county;
  - A city and a local agency or local agencies located entirely within that city;
- To finance a facility for which an authority has received an allocation from the California Debt Limit Allocation Committee;
- Of an authority that consists of no less than 100 local agencies and the agreement that established that authority requires the governing body of the local agency that is a member of the authority in whose jurisdiction the facility will be located to approve the facility and the issuance of the bonds.
