The 504 Loan Officer should be knowledgeable about all programs offered by Colorado Lending Source and maintains a special degree of expertise regarding the Small Business Administration 504 loan program. The Loan Officer will originate new loan projects and work with partner lenders and small business owners from origination through funding. He or she must be able to independently analyze potential business clients and use discretion and judgment to identify if the project meets the mission of Colorado Lending Source by providing economic development to the community it serves. This position will also be responsible for marketing and business development duties within the Colorado Lending Source territory and provide excellent customer service to all parties involved in the process.

Position Responsibilities:

- Understand all aspects of loan programs offered at Colorado Lending Source and be an expert regarding the SBA 504 loan program
- Loan Origination Meet with prospective clients and partner lenders and determine eligibility and viability of proposed projects
- Underwriting Prepare complete financial analysis and loan presentations that accurately portray the project to both the Colorado Lending Source Loan Review Committee and the Small Business Administration
- Review appraisal and environmental reports and determine if they meet SBA requirements
- Business Development Develop new relationships with partner lenders and other financial resources; participate in trainings and events that meet the mission of Colorado Lending Source
- Provides support and oversight to the small business owner and lender throughout application process
- Any other tasks associated with this position
