The IDA is a self-funded, quasi-public entity governed by a seven-member Board. Board members are nominated from the community and confirmed by the Mayor and Council.

Job Summary

Entrepreneurial minded, finance/economic development executive is needed to lead the Tucson Industrial Development Authority ("Tucson IDA"), in concert with its Board of Directors. This is a new position, and will lead the overall growth of the Tucson IDA with the strategic guidance and support of the Board members.

The ideal candidate will have the following background and skill sets:

- Bachelor's and/or master's degree in finance, business administration, or relevant major
- Understanding of tax-exempt bonds, real estate development, and finance in economic development and business environments (Arizona experience a plus)
- Demonstrated leadership skills in business development and project management
- Ability to envision emerging markets, develop creative financing opportunities, and explore and implement innovative business opportunities
- Ability to interact and develop relationships with high-level corporate executives, public finance and banking professionals, Arizona, Pima and City organizations and elected officials (e.g., Housing Authorities, government, funding agencies), and community leaders
- Entrepreneurial and goal-oriented with the ability to execute at a high level
- Ability to understand and lead social media and internet outreach/networking and marketing

Background Information

The current Tucson IDA Board is determined to support building a team to implement our 2021 strategic plan. Our new Executive Director will have the opportunity to build and staff a competitive organization that leverages the available development finance toolbox in dramatically growing the impact of our IDA.

With assets of roughly \$4M and ongoing revenue from programs and income-producing property, the Executive Director will have capital and resources to execute the IDA's vision and strategy. Our current programs include first-time homebuyers' loans, small business loans, and bond financing.
