As a Finance Manager at **Business Oregon**, Mr. Saris demonstrated incredible leadership and expertise by successfully managing technical and financial assistance programs, innovative certification programs, and job creation initiatives. Through the department's direct loan, loan guarantee, and conduit bond programs for small businesses, he helped leverage over \$2 billion in funding and create over 10,000 jobs since 2009.

As the manager of the Certification Office for Business, Inclusion & Diversity (COBID), primarily responsible for certifying minority, women, emerging, disadvantaged, or veteran businesses, Mr. Saris enabled historically disadvantaged individuals to effectively compete for public procurement opportunities and reach their funding goals. Mr. Saris further assisted with the administration and oversight of the Business, Innovation & Trade Division of Business Oregon through which he helped facilitate pass-through funding for technical service providers such as the Small Business Development Center Network and the Oregon Manufacturing Extension Partnership.

Mr. Saris also served on the CDFA Board of Directors from 2010 until 2023, providing invaluable insight and support to CDFA and its members.
