

8(a) Business Development Program

Administrative Agency:

Federal Agency: U.S. Small Business Administration (SBA)

Program Goals:

BN\$

8(a) Business Development Program's goals are:

- To promote the business development of small business concerns owned and controlled by socially-and economically-disadvantaged individuals, so they can compete on an equal basis in the American economy.
- To promote their competitive viability in the marketplace by providing such available contract, financial, technical, and management assistance as may be necessary.

Resource Provided:

SBA monitors all federal government contracts to ensure that a percentage of contract work goes to small businesses designated as 8(a) businesses. SBA also provides business management services to assist these 8(a) business concerns in their development.

Eligibility:

A business must qualify as a small business concern under SBA's size standards (13 CFR 121). A qualifying individual(s) must be the majority owner of the business and must be involved in the day-to-day management of the business. Additionally, small business concerns owned by Indian tribes and Alaska Native corporations may be eligible. A business must be approved for program participation prior to receipt of an 8(a) contract.

Alaska Program Status:

The Anchorage SBA Office maintains a list of approved 8(a) businesses (construction, professional and nonprofessional services, and manufacturing). SBA receives contracts for services from other federal agencies and then subcontracts the performance of these services out to qualified 8(a) firms.

Comments:

This program experiences great demand. 8(a) contract opportunities are used as a resource in the development of the applicant's business but are not guaranteed. A related SBA program provides for business management services to 8(a) businesses. A separate SBA program monitors all federal contracts to ensure that a predetermined percentage is awarded to small businesses.

Federal Agency: U.S. Department of Health and Human Services, Administration for Children and Families (ACF), Administration for Native Americans (ANA)

Program Goals:

Program announcements are goal-category specific. ANA will release separate program announcements for funding opportunities under Social and Economic Development Strategies (SEDS); Language: Assessment, Planning, Implementation, and Immersion; Environmental Regulatory Enhancement; Family Preservation: Planning and Implementation; and for special initiatives.

- Governance: to assist tribal and Alaska Native village governments, Native American institutions, and local leadership to exercise local control and decision-making over their resources.
- Economic Development: to foster the development of stable, diversified local economies and economic activities, which provide jobs and promote economic well-being.
- Social Development: to support local access to, control of, and coordination of services
 and programs that safeguard the health, well-being, and culture of Native Americans
 and provide them with the support services and training necessary for them to work and
 sustain services that are essential to a thriving and self-sufficient community.

Eligibility:

Tribal entities and private nonprofit agencies with Native entity status.

Alaska Program Status:

In autumn 2009, there were 23 active ANA grants in Alaska in all categories of ANA funding areas.

Comments:

Alaska Region III has a website that lists free pre-application workshops with current dates and Alaska training locations. Nonprofit organizations are eligible if the majority of board seats are held by Alaskan Natives. Building funds are ineligible for funding, but construction design is eligible. Free telephone technical assistance is also available.

Note: Applicants must be or belong to a recognized tribal or Native entity.

State Agency: Department of Natural Resources (DNR), Division of Agriculture, Board of Agriculture and Conservation (BAC)

Program Goals:

To promote development of agriculture as an industry in Alaska through low-interest rate loans for product processing, land clearing, equipment/livestock purchase, and farm development.

Resource Provided:

Direct loans: operating loans up to \$200,000, chattel loans up to \$1,000,000, product processing and land clearing loans up to \$250,000, farm development loans up to \$1,000,000. All loans are limited to 75% of the value of collateral.

Eligibility:

Individuals, partnerships, or corporations who are Alaska residents or headquartered in Alaska and owned by Alaskan residents. Loans are available on the basis of generally accepted banking practices.

Alaska Program Status:

There are approximately 115 accounts active statewide with a value of approximately \$12 million.

Resource Provided:

Technical advisory services and counseling in the area of efficient market development. Provides product grading, marketing support programs, and facilitation of commercial agricultural transactions.

Eligibility:

Government agencies and private industry (producers, processors, or marketing agencies) may request assistance.

Alaska Program Status:

DNR has a three-person staff, two in Palmer and one in Fairbanks, who provide a state-level clearinghouse service concerning agricultural development resources.

Comments:

The program uses sound marketing information to bring producers, wholesalers, and retailers together.

Alaska Capstone Avionics Revolving Loan Program

Administrative Agency:

State Agency: Department of Commerce, Community, and Economic Development (DCCED), Division of Investments

Program Goals:

To provide long-term, low-interest financing for the purchase and installation of Capstone avionics equipment for private and commercial aircraft that are substantially flown in Alaska.

Resource Provided:

Loans are available for the purchase and installation of Capstone avionics equipment for private and commercial aircraft that are substantially flown in Alaska. The applicant must sign a declaration certifying that the aircraft being upgraded has flown at least 51% of its flight hours in Alaska over the last 12 months.

Collateral: Loans will be secured by a priority lien on the avionics being financed and by a lien on the aircraft receiving improvement.

Eligibility:

Aircraft being upgraded must be substantially operated in Alaska. Applicant must sign a declaration certifying that at least 51% of the aircraft's flight hours were in Alaska over the last 12 months.

Applicant must provide copy of airworthiness certificate, copy of aircraft registration, and copy of last tax return.

Alaska Program Status:

The effective date of this program was July 1, 2007.

Comments:

Interest rate is 4%. There is a \$50.00 non-refundable application fee. Maximum loan term is 10 years. Payment schedule is requested at closing and is either monthly, quarterly, semi-annual, or annual. Borrower is responsible for paying all direct costs incurred in processing the loan application, including, but not limited to, an aircraft preliminary title report and FAA recording fee.

Eligibility:

Eligible projects are broadly defined as film, documentary, advertising, and video projects. At least \$100,000 of qualified expenditures must be made in Alaska, although there are no salary caps or project caps. Companies do not need to be domiciled in Alaska nor do they need to hire Alaskans. However, there are additional incentives for Alaska hire, off-season production, and productions filmed in rural locations. Productions receive 30% base credit for all expenditures made in Alaska, an additional 10% tax credit for wages paid to Alaskan residents, 2% tax credit for production expenditures made between October 1 and March 30, and a 2% tax credit for production expenditures made in a rural area, for a combined maximum possible credit of 44% for a production with an all-Alaskan crew that films in Alaska between October and March.

Alaska Program Status:

Funding for the Transferable Tax Credit is set by legislation at a minimum of \$100,000.

Projects proposed for the FLP in Alaska must be threatened by conversion to non-forest uses and must directly address one or more of the Alaska program goals. Participation in Forest Legacy is limited to private forest landowners.

The Bond Bank was created to address the disadvantages that Alaska's communities often experience in financial markets. Communities may have low bond ratings or lack familiarity among investors that would result in above-market interest rates on borrowed money.

Generally, the Bond Bank sells bonds on the national money market and then uses the proceeds to purchase the bonds of Alaska municipalities at the same interest rate the Bond Bank obtained, thereby providing the municipalities with funds for their capital projects. The Bond Bank's A rating from both Moody's and Standard and Poor enables it to borrow money at low rates. As municipalities pay principal and interest to the Bond Bank, the Bond Bank uses this money to pay its bond holders.

The Bond Bank is self-supporting. It does not use general fund monies and, in fact, has returned up to \$2.2 million to the general fund annually. The bank has an excellent loan record, with no defaults.

The bank has five directors, including the Commissioners of the Departments of Revenue and Commerce, Community, and Economic Development, as well as three public members.

- Aid in the prevention or elimination of slums or blight
- Meet other community development needs having a particular urgency, because existing conditions pose a serious and immediate threat to the health and welfare of the community and other financial resources are not available to meet such needs

Some of the eligible activities include:

- Acquisition of real property.
- Clearance and demolition.
- Rehabilitation of residential structures and compliance with the accessibility requirements contained in Section 504 of the Rehabilitation Act of 1973 and Americans with Disabilities Act of 1990.

The product preference programs (Alaska Products, Forest Products) do not provide direct financial assistance. Under the state procurement code, however, these two programs can provide eligible manufacturers cost preferences of 3%, 5%, or 7% on state procurement contracts.

Eligibility:

Any Alaskan business that manufactures a product with at least 25% value-added in Alaska may submit an application to the Commissioner of the Department of Commerce, Community, and Economic Development for certification in one of the preference programs. Certification in the preference programs is awarded to a qualifying product, not to its manufacturer. The department verifies information submitted on the application, and, if approved, the product is certified for a two-year period. After certification, the product is included in the next published semi-annual Product Preference List. Product Preference Lists are published April 1 and October 1.

Assisted-Living Conversion Program (ALCP)

Administrative Agency:

Federal Agency: U.S. Department of Housing and Urban Development

Program Goals:

To provide non-profit owners of eligible developments with a grant to convert some or all of the dwelling units in a project into an Assisted-Living Facility (ALF) for the frail elderly. The facility must be licensed and regulated by the state or, if there is no state law providing such licensing and regulation, by the municipality or other subdivision in which the facility is located.

ALFs are designed to accommodate frail elderly and people with disabilities who can live independently but need assistance with activities of daily living (e.g., assistance with eating, bathing, grooming, dressing, and home management activities). ALFs must provide support services such as personal care, transportation, meals, housekeeping, and laundry.

Resource Provided:

Typical funding will cover basic physical conversion of existing project units and common and services space. The ALCP provides funding for the physical costs of converting some or all of the units of an eligible development into an ALF, including the unit configuration, common and services space, and any necessary remodeling consistent with HUD or Alaska's statute/regulations (whichever is more stringent). There must be sufficient community space to accommodate a central kitchen or dining facility, lounges, recreation, and other multiple areas available to all residents of the project or office/staff spaces in the ALF. Funding for the supportive services must be provided by the owners either directly or through a third party.

Eligibility:

Eligible Grantees: Only private non-profit owners of Section 202 and Section 8 project-based housing developments, designated to be occupied primarily by the elderly for at least five years, are eligible for funding. These eligible properties also include those funded by Rural Housing Services - Section 515, Section 221(d) (3) BMIR or Section 236 programs. A private non-profit of an unused/underutilized commercial property is eligible as well.

Application: Applicants must submit an electronic application for funding in response to the Notice of Funding Availability (NOFA) published in the Federal Register each fiscal year. Applicants that apply for the Assisted-Living Conversion Program compete for program funds allocated to each individual Multifamily Hub Office. Awards are generally announced in the fall. To apply to AIDEA for a guarantee, a \$200 non-refundable application fee is required. AIDEA charges a one-time guarantee fee of 2% on the guaranteed amount. An abbreviated application process is available for new loan guarantees of \$100,000 or less. Loan terms range from one to twenty years, depending upon the use of loan proceeds and collateral offered as security for the loan. The maximum interest rate that may be charged by the bank is prime rate plus 2.75%.

Coastal Wetlands Conservation Grant Program

Administrative Agency:

Program Goals:

The program assists Alaskans to acquire, restore, manage, and enhance their coastal wetland resources. This program is managed by the Alaska Department of Natural Resources, Division of Parks and Outdoor Recreation.

Resource Provided:

The program is funded under provisions of the federal 1990 Coastal Wetlands Planning, Protection, and Restoration Act with money generated from excise taxes on fishing equipment and motorboat/small engine fuels. Under the program, U.S. Fish and Wildlife Service provides matching grants to states for acquisition, restoration, management, or enhancement of coastal wetlands.

States provide 50% of the total costs of a project; Alaska, however, has an established program (the Duck Stamp program) that also focuses on coastal wetlands; the federal share is 75%.

This is a nationally competitive grant program, based on criteria contained in 50 CFR 84. Projects are given priority if they are consistent with the National Wetlands Priority Conservation Plan, are located in states with dedicated land acquisition programs, or are located in maritime forests on coastal barrier islands. Additional consideration may be given to projects that benefit threatened and endangered species, encourage cooperative efforts, and support other ongoing projects. Grants awarded cannot exceed \$1.0 million for an individual project. Applications are prepared and submitted to US Fish and Wildlife Service by the State of Alaska in June of each year.

Alaska's annual allotment in FY 09 was \$1,534,490 for guaranteed loans, \$2,156,000 for direct loans, \$3,504,000 ARRA direct loans, and \$200,380 in grants. Additional funds can be obtained from a national reserve. Special Economic Impact Initiative Grant funding varies.

Comments:

Loans have a maximum term of 40 years or the useful life of the facility, whichever is less. Interest rates are set periodically and are based on current market yields for municipal obligations. The current range of interest rates on direct loans is 4.125% to 4.50%. All loans will be adequately secured.

Program Goals:

AIDEA has the ability to develop, own, and operate projects necessary to support Alaskan economic development.

Resource Provided:

- Bulk Fuel Revolving Loan Fund (BFRLF): Assists small rural communities in purchasing bulk fuel supplies. Loan may not exceed 90% of the wholesale price of the fuel purchased plus transportation costs; maximum loan is \$750,000. The loan must be repaid within one year. There is no interest on the first BFRLF loan; 5% interest applies for the second BFRLF loan; and an interest rate based on the average weekly yield of municipal bond rates applies to additional loans. Loans may be made to municipalities or unincorporated villages with less than 2,000 or to private individuals, corporations, and cooperatives, with a written endorsement from the local governing body.
- Power Project Revolving Loan Fund: Provides loans to local utilities, governments, or independent power producers to develop or upgrade power facilities, including conservation, bulk fuel storage, and waste energy conservation, or water supply projects. Loan term is related to the life of the project. Interest rate ranges between zero and a rate based on the average weekly yield of municipal bond rates.

The Farm and Ranchland Protection Program (FRPP) is a voluntary program that helps farmers and ranchers keep their land in agriculture and prevent conversion of agricultural land to non-agricultural uses.

The program provides matching funds to state, tribal, and local governments and allows non-governmental organizations with existing farmland protection programs to purchase conservation easements. These entities purchase easements from landowners in exchange for a lump-sum payment, not to exceed the appraised fair market value of the land's development rights.

Eligibility:

LAND: Entire farms or ranches may be enrolled in FRPP. The farmland or ranch land must contain at least 50% of prime, unique, statewide, or locally important soil or contain historic or archaeological sites. These lands must also be subject to a pending offer from an eligible entity for the purpose of limiting conversion of the land to non-agricultural uses. Eligible land includes cropland, rangeland, grassland, pasture land, and forest land that is part of an agricultural operation.

ENTITY: An eligible entity must be a federally-recognized tribe, state or local agency, or a non-governmental organization that:

- is organized principally for the preservation of land for recreation, open space, historical preservation, and natural habitat
- is operated exclusively for charitable, religious, or educational purposes
- normally receives more than one-third of its support from any combination of gifts, grants, contributions, or membership fees.

A hydro project is being constructed in Atka in support of the fishing industry, and other recent electrical projects have taken place in Ketchikan and Petersburg. A recycling center in Palmer and publically-owned visitor industry investments, such as the Alaska Native Heritage Center and the Chilkat Indian Village Facility in Klukwan, are among EDA investments. These range from \$200,000 to \$5 million, though they are typically under \$3 million.

Comments:

Project proposals are submitted to the Anchorage EDA office for review, then to the EDA Regional Office (combined Regions IX & X) for recommendation to Central Office for approval. There is a preference for high local match and low cost jobs. Alaska funding is usually in the range of \$8 to \$12 million annually. Grant requests should normally be no smaller than \$500,000, should create or save at least one private sector job per \$10,000 of federal grant, and should have as high a percentage of non-federal match as possible, often 50% or more. Major private sector partner investments that come as result of the EDA investment are a big plus.

Indian Community Development Block Grant Program (ICDBG)

Administrative Agency:

Federal Agency: U.S. Department of Housing and Urban Development (HUD), Office of Native American Programs (ONAP)

Program Goals:

To provide assistance to Indian tribes and Alaska Native villages in the development of viable communities, including decent housing, a suitable living environment, and expanding economic opportunities, principally for persons of low and moderate income.

Resource Provided:

Primarily construction grants, except for economic development projects, where there is added flexibility. The maximum grant amount is \$600,000. There are grant categories for housing, community facilities, economic development, and imminent threat to health and safety.

ICDBG funds are distributed as annual competitive grants. Funds are allocated to each of the six Area Offices of Native American Programs (AONAP), so applicants compete for funding only with other tribes or eligible Indian entities within their area.

Eligibility:

Eligible Grantees: All federally-recognized tribes and Alaskan Native villages or tribal organizations working on behalf of Indian tribes are eligible to participate in the ICDBG program.

Eligible Customers: Projects funded by ICDBG must primarily benefit low- and moderate-income persons (generally defined as members of low- and moderate-income families that earn no more than 80% of the median income in the area).

Eligible Activities: ICDBG funds may be used to improve the housing stock, provide community facilities, improve infrastructure, and expand job opportunities by supporting the economic development of the communities, especially by non-profit tribal organizations or local development corporations. Tribes and Alaskan Native villages are restricted from using block grants for construction or improvement of governmental facilities, government operations, and income payments. Eligible activities include:

- Acquisition of property
- Assistance to institutions of higher learning
- Assistance to Community-Based Development Organizations (CBDOs)
- Clearance and demolition
- Code enforcement
- Comprehensive planning
- · Energy efficiency
- · Lead-based paint abatement and evaluation

Program Goals:

To provide financing assistance to business projects in Alaska by purchasing participation in loans originated by financial institutions for the financing of taxable facilities, such as retail stores, hotels, office buildings, plants and equipment, and specific tax-exempt project facilities.

AIDEA can purchase up to 90% of the loan or up to \$20,000,000 (whichever is less) from the financial institution originating the loan. The total loan amount cannot exceed 75% of the value of the collateral offered as security for the loan.

AIDEA had approximately \$368.2 million outstanding in loans as of June 30, 2009.

Borrowers apply at a financial institution for a loan. The financial institution, after approval of the loan, applies to AIDEA for participation in the loan. The application to AIDEA must be accompanied by a \$1,000 non-refundable application, which is credited toward the commitment fee if the loan participation is approved and accepted. Other fees include a 1% commitment fee on AIDEA's portion of the loan. Terms can be up to 15 years for personal property or 25 years for real property, not to exceed 75% of the remaining economic life of the collateral. Both fixed and variable interest rates are available.

Eligibility:

A person who makes or manufactures an eligible product or produces an eligible handcrafted item in the state may apply to the Made in Alaska Program, currently managed by Webb's Consulting & Management Services, Inc., for an annual permit to use the Made in Alaska emblem on a qualifying product. It should be noted that the permit applies to the qualifying product, not to the manufacturer or producer. To be awarded a permit, an applicant must: have a manufacturing or production site and accomplish the majority of value-added processes within the state, use Alaska origin materials wherever possible, allow an inspection of the manufacturing or production site, and have a current Alaska business license. A separate permit is required for each handicraft or product line.

Funding for the program varies from year to year, but program administration is ongoing.

Marketing Assistance Loans/Loan Deficiency Program

Loan Deficiency Program payments are price support payments.

Marketing Assistance Loans are non-recourse, because the producer pledges the crop as collateral and has the option of delivering the pledged commodity to the Commodity Credit Corporation as full settlement of the loan at maturity. The producer must sign up for the program each year and must certify their crop acreage each year as part of the program. Loan Deficiency Payments are for producers who forego the Marketing Assistance Loans. This price support payment is limited to actual production.

Alaska Program Status:

Loan Deficiency Payments have been available in Alaska since June 2005 when loan rates were adjusted to more accurately reflect the market conditions in local areas, thus allowing for the possibility of payments.

Power Cost Equalization (PCE) Program

Administrative Agency:

State Agency: Alaska Energy Authority (AEA), Department of Commerce, Community, and Economic Development (DCCED)

Program Goals:

To try to equalize high costs of electricity in rural communities with the lower costs in more urban areas through direct-rate reductions. Communities not on the road or barge system experience very high costs to produce electricity (usually with diesel), due to high transportation costs and high diesel prices. These high costs must be recovered from the limited number of customers with limited disposable income associated with generally low economic development.

Eligibility:

Rural utilities are eligible for PCE assistance, with the exception of the Railbelt electric utilities, AEL&P (Juneau), and those utilities that receive electric power from the Four Dam Pool facilities (Ketchikan, Wrangell, Petersburg, Kodiak, Glennallen, and Valdez). An eligible residential customer may receive PCE credit on up to the first 500kWhs consumed each month.

Community facilities are also eligible to receive PCE credit on up to a maximum of 70kWh per month multiplied by the community population. For example, a community of 100 would receive credit on up to 7,000 kwhs for its combined community facilities.

State and federal customers, as well as commercial customers (including schools), are not eligible for PCE credit.

As of June 2009, there were 29 loans valued at \$3.5 million.

Comments:

There is a \$100 application fee. A 1% origination fee is due at closing. All expenses incurred by the department in processing the application must be paid by the applicant. Expenses may include the cost of title insurance, recording fees, appraisals, travel, or other direct costs.

Loan funds generally may not be used to reimburse costs incurred more than six months prior to submitting an application. The funds generally may not be used to refinance long-term debt. A person who has an existing loan under this program may not be granted another loan until the original loan has been repaid. Loans must be secured by adequate collateral, such as a mortgage or other security instrument, real property, or other tangible assets.

Eligible Activities: Possible activities include preparation of plans or architectural drawings, acquisition of land and buildings, demolition, provision of infrastructure, purchase of materials and construction costs, use of local labor markets, job training and counseling for beneficiaries, and financial services such as revolving loan funds and Individual Development Accounts (IDAs). Other possible activities include: homeownership and financial counseling; application of innovative construction methods; provision of financial assistance to homeowners, businesses, and developers; and the establishment of CDFIs, lines of credit, revolving loan funds, microenterprises, and small business incubators.

Alaska Program Status:

Application: After HUD publishes a Notice of Funding Availability (NOFA) for the Rural Housing and Economic Development Program, applicants must submit specific information about a proposed project or activity in their application. Applicants must meet SBA size standards for small businesses. Credit criteria are much the same as used by banks. Applicants must work with a lending institution that will, in turn, arrange the loan guaranty with SBA.

Eligible projects are business real estate, inventory purchases, machinery and equipment, leasehold improvements, working capital, and, in some circumstances, debt consolidation.

Small Business Economic Development Revolving Loan Fund

Administrative Agency:

State Agency: Department of Commerce, Community, and Economic Development (DCCED), Division of Investments

Program Goals:

To create significant long-term employment and diversify the economy by providing start-up and expansion capital for small businesses. Emphasis is placed on projects that promise the greatest long-range positive economic impact on a community.

Resource Provided:

Financing of either industrial or commercial ventures will be considered. The interest rate is prime minus 4%, is no less than 4%, and is fixed at the time of loan approval. The term of the loan will be determined by the Loan Administration Board. The maximum loan term is 20 years. The maximum loan amount is \$300,000, and the minimum is \$10,000.

Eligibility:

Applicants will be required to obtain additional private, non-public financing, generally in an amount not less than twice the amount requested under the application. Loans may be made to companies that are located in rural areas, as defined by the program guidelines, and are small businesses, as defined by the U.S. Small Business Administration.

Alaska Program Status:

The fund is established by statute and funded jointly by the state and the U.S. Economic Development Administration (EDA). As of June 2009, there were 58 loans valued at \$6.2 million outstanding.

Comments:

In order to be funded, the project must be located in an eligible area (affected by high unemployment, low average income, etc.) as determined by the EDA. There is a \$200 application fee and a 1% origination fee due at closing.

Southeast Alaska Revolving Loan Fund

Administrative Agency:

Nonprofit (Alaska): Juneau Economic Development Council (JEDC)

Program Goals:

The Southeast Alaska Revolving Loan Fund (RLF) was established to help business owners create and retain quality jobs throughout Southeast Alaska. The RLF makes direct loans to new and expanding business that cannot qualify for traditional bank financing but which otherwise appear likely to succeed.

Resource Provided:

Direct short-term (up to 5-year) loans for projects located within the municipal boundaries of Juneau, Hoonah, and Haines under separate revolving loan funds have been created for each of these communities. The RLF also makes direct loans throughout Southeast Alaska (except in Juneau) through its USDA Intermediary Relending Program (USDA-IRP). Loans range in size from \$5,000 to \$300,000, based on need, funding, program limits, and the availability of traditional or other financing. The RLF can help arrange multi-creditor financing for larger projects and typically attempts to leverage its loan funds with banks or other public and private financing.

Eligibility:

The maximum loan amount is determined in part by the number of jobs created or saved by the borrower's business. One full-time equivalent position is required for each \$30,000 of RLF loan funds. Preference is given to applicants providing manufacturing or highly-paid jobs. Juneau-based loans require bank participation. Applicants may not have delinquent obligations owed to federal, state, or local governments. The primary criteria for consideration are dedicated and experienced management, past performance, current economic viability of the business, and clear competitive advantages. All applicants must have a complete and current business plan. Potential applicants are encouraged to call to discuss their project before applying.

The RLF provides financing for most business needs, including debt refinancing, purchase of fixed assets, permanent working capital, construction, and leasehold improvements.

Loans are priced to reflect risk and to encourage businesses to "graduate" to conventional bank financing as soon as possible. Each financing package is customized to meet the overall cash flow needs of the business. Extensive technical assistance is provided before and throughout the loan term by the RLF and Juneau Economic Development Council's business counselors, timber industry experts, and extensive network of consultants and business contacts, who will help entrepreneurs with financial management, marketing, manufacturing processes, and general business management to ensure each borrower's business succeeds and the jobs created are sustainable.

Successful loan applicants also are referred to Tlingit Haida Central Council's business counselors and the business counselors at the Juneau and Ketchikan Small Business Development Centers.

Program Goals:

The State Training and Employment Program (STEP)'s purpose is to:

- Enhance the quality of in-state job training and employment assistance and to make in-state job training and employment assistance more easily available to employers, employees, and future employees
- · Prevent future claims against unemployment benefits
- Attract new businesses through the availability of a skilled labor force and reduction of employer unemployment insurance costs
- Ease the impact of Alaska's economic fluctuations through training or retraining of workers for new and/or emerging industries and technologies
- Promote local hire.

Resource Provided:

STEP is funded by one tenth of one percent (.1%) of employee contributions to the Unemployment Insurance (UI) Trust Fund. These employee contributions are deposited in a special Employment Assistance and Training Program Account within the state General Fund and are accessed through grants or individual training vouchers.

Eligibility:

Job training for persons who:

- Are unemployed and receiving unemployment insurance benefits
- Have exhausted their UI benefits
- Are employed but likely to lose their job due to the job's elimination or due to obsolescence of their job skills
- Worked in a job covered by UI but are ineligible for benefits because the job was seasonal, temporary, or part-time and/or wage contributions were insufficient
- Are underemployed.

Alaska Program Status:

STEP was created by the legislature in 1989 to be more responsive to Alaska job market conditions and be more flexible than federally-funded training programs. The legislature made the STEP program permanent April 19, 2009, and it was approved by the governor on June 20, 2009.

Program Elderly and Persons with Disabilities Grants and Program Rural Capital and Operating Grants are selected competitively. Grants are provided based on reimbursements for allowable expenditures. (Funds are not provided in advance of expenditures.)

- Community projects may become part of larger Regional Transportation Plans (Southeast, Southwest, Y-K Delta, Northwest, Interior and Copper River Delta Regions) and include a public process.
- The project is scored by DOT Regional and Statewide Offices.
- Projects must be a public asset (road, trail, ferry, bus) and no restrictions or limitations
 are permitted as to who may use the facility.
- Because of the complexity of the rules governing the use of federal highway funds, projects are generally not delegated to the applicant. Instead, Alaska DOT&PF will oversee the design and construction of successful projects.

Alaska Program Status:

Last year, Alaska received about \$250 million of federal aid transportation funding for discretionary use on surface transportation improvement projects. Nominations for Community Transportation (CTP) and Trails and Recreational Access (TRAAK) projects are normally evaluated for funding every two years; however, due to an expected downturn in federal aid, ADOT&PF may need to limit the number of new CTP and TRAAK projects considered each cycle. Funding in 2010 and beyond is dependent upon reauthorization of the federal highway program. Though no decision has yet been made, significant changes in funding, eligibility, and limitations appear likely. Thus, future opportunities to access these funds cannot be guaranteed.

Nominations for transit human services-related grants will continue to be evaluated and awarded under competitive Alaska Mental Health Trust, Federal Transit Administration (FTA) Elderly and Persons with Disabilities, New Freedom Beyond the ADA, and Job Access and Reverse Commute programs. Public transit funds are provided through a formula process.

Western Alaska Fisheries Disaster and Norton Sound Fisheries Disaster grants were also issued under this program. Facilities grants are frequently in the \$500,000 to \$2.5 million range. The Kenai Peninsula EDD, Prince William Sound EDD, Southeast Conference, and Southwest Alaska Municipal Conference are EDDs and ARDORs. The five Regional Native Tribal grants currently go to: Central Council of the Tlingit and Haida Indian Tribes of Alaska (THCC), Bristol Bay Native Association (BBNA), Association of Village Council Presidents (AVCP), Kodiak Area Native Association (KANA), and Kawerak (also an ARDOR through the Bering Strait EDC). Occasional one-time CEDS planning grants may be available.

Comments:

Funding is limited and competition is strong. Regional administrative grants usually range from \$50,000 to \$70,000 annually. Grants may be renewed annually if grantee's performance and proposed work plan are acceptable.

Supportive Housing for Persons with Disabilities -Section 811

Administrative Agency:

Federal Agency: U.S. Department of Housing and Urban Development

Program Goals:

To develop rental housing with the availability of supportive services for very low-income adults with disabilities and to provide rent subsidies to projects that will make them affordable.

Resource Provided:

HUD provides interest-free capital advances to non-profit sponsors to help them finance the development of rental housing, such as independent living projects, condominium units, and small group homes with supportive services for persons with disabilities. The capital advance can finance the construction, rehabilitation, or acquisition (with or without rehabilitation) of supportive housing.

The advance does not have to be repaid as long as the housing remains available for at least 40 years to very low-income persons with disabilities.

HUD also provides project rental assistance; this covers the difference between the HUDapproved operating cost of the project and the amount the residents pay -- usually 30% of adjusted income. The initial term of the project rental assistance contract is three years and can be renewed if funds are available.

Each project must have a supportive services plan. The appropriate state or local agency reviews a potential sponsor's supportive services plan to determine if the plan is welldesigned to meet the needs of persons with disabilities and must certify to the same. Services may vary with the target population but could include case management, training in independent living skills, and assistance in obtaining employment. However, residents cannot be required to accept any supportive service as a condition of occupancy.

Eligibility:

Eligible Grantees: Non-profit organizations with a Section 501(c) (3) tax exemption from the IRS can apply to develop a Section 811. Occupancy of Section 811 housing is open to persons with disabilities. A qualified person must be 18 years or older and must have a disability meeting one or more criteria outlined in HUD Handbook 4571.2 (p. 1-5 to 1-6).

Alaska Program Status:

The available program funds for a fiscal year are allocated to HUD's local field offices. Notice of Funding Availability for this program is announced each spring to solicit applications.

Comments:

Applicants must submit an electronic application for a capital advance, including a Request for Fund Reservation (Form HUD-92016-CA) and other information in response to a Notice of Funding Availability (NOFA) published in the Federal Register each year. Applications must be submitted electronically at http://www.grants.gov.

Those selected for funding must meet basic program requirements, including non-profit status, financial commitment, and a certification from the appropriate state or local agency stating that the supportive services are well-designed to meet the needs of the intended residents. Awards are usually announced in the fall.

Trade Adjustment Assistance Program

Administrative Agency:

Program Goals:

The Trade Adjustment Assistance program (TAA) is a voluntary program for agricultural producers that offset the adjustment to competition from imports by providing cash payments and opportunities for job retraining. Certain fishermen and aquaculture producers may also qualify for TAA benefits.

Resource Provided:

Cash payments.

Eligibility:

Producers must submit a petition for a commodity to be approved for payments. After the commodity is approved or recertified by the Foreign Agriculture Service, all producers in an impacted area may apply for TAA benefits within the application period. Producers must document income and technical training requirements and meet specific eligibility requirements.

Alaska Program Status:

As of time of publication, this program is not currently available in Alaska, although it has been in years past, based on petitions filed for salmon. Over \$5.5 million was paid out in Alaska over two years.

Comments:

Eligible Alaska commodities have included salmon. Nationally, other petition commodities have included shrimp, olives, fresh potatoes, cabbages, apples, and oranges.

Value-Added Producer Grant

Village Safe Water (VSW) Program

Administrative Agency:

State Agency: Department of Environmental Conservation, Division of Water

Program Goals:

The role of the Village Safe Water Program is to work with rural communities to develop sustainable sanitation facilities. Goals of the program are to:

- Achieve accountability and performance excellence on projects
- Plan and advocate for sustainable facilities
- Promote staff learning, growth, and innovation
- · Secure stable and diverse funding sources

Resource Provided:

The core services of the program are:

- To allocate and distribute funding for water and sewer studies and design/construction projects
- To administer grants according to the requirements of the funding sources
- To deliver projects by managing and completing project requirements

Eligibility:

To be eligible for funding under the Village Safe Water Program, the applicant must be an unincorporated community that has between 25 and 600 people residing within a two-mile radius, a second-class city, or a first-class city with no more than 600 residents.

Alaska Program Status:

In May 2009, the program received \$24,260,000 in funding from the Indian Health Service (IHS) as part of the American Recovery and Reinvestment Act of 2009 (federal stimulus funding). Also, for state Fiscal Year 2010, the program received \$20,050,387 in funding from EPA, of which the state provided a 25% matching share. In addition, VSW receives additional funding from IHS each year, which has averaged about \$10 million for the past five years. Annual federal funding amounts have been decreasing 30% since 2006.

Comments:

VSW's capital funding allocation system is called the Capital Improvements Project (CIP). IHS's funding allocation system is called the Sanitation Deficiency System (SDS), which is a national system that captures all unmet needs of Native Alaska villages and Lower-48 Indian reservations.

Each system allocates funds annually for projects, and both were united in 2006 into one common database of unmet sanitation needs in rural Alaska. Together, the CIP and SDS allocate about 90% of all federal and state funding for rural sanitation projects in Alaska, with an annual average of \$100 million since 2001. Water and Waste Disposal Loans and Grants

Public entities such as cities, boroughs, federally-recognized Alaska Native tribes, and non-profit corporations.

Comments:

The 2009 FY allocation was \$7,062,000 in loans, \$933,000 in loan guarantees, and \$2,390,000 in grant funds. Loans have a maximum term of 40 years. Interest rates are set periodically and are based on current market yields for municipal obligations. Grants may be made for up to 75% of eligible facility development costs.

Watershed Protection Programs

Administrative Agency:

Federal Agency: U.S. Department of Agriculture, Natural Resources Conservation Service (NRCS)

Program Goals:

To prevent flood and erosion damage and further the conservation and utilization of land and water.

Resource Provided:

Technical and financial assistance.

Eligibility:

Public and private landowners, state or local governments, and qualified Alaska Native tribes or tribal organizations. For the Small Watershed Program there must be a sponsoring local organization.

Eligible projects must employ measures that are adequate, safe, economically and environmentally defensible, and technically sound and must meet other requirements in federal statutes and regulations.

Alaska Program Status:

Small watershed projects have been funded in the Badger Road Watershed, sponsored by the Fairbanks North Star Borough and Fairbanks Soil and Water Conservation District, and the Delta Clearwater River Watershed, sponsored by the Salcha-Big Delta Soil and Water Conservation District and the State of Alaska.

Emergency watershed assistance has been provided to the rural communities of Noatak, Fort Yukon, Eagle, Dillingham, and Unalakleet.

Western Alaska Community Development Quota (CDQ) Program

Administrative Agency:

Federal Agency: U.S. Department of Commerce, National Oceanic and Atmospheric Administration; Alaska Department of Commerce, Community, and Economic Development; Alaska Department of Fish & Game; National Marine Fisheries Service (NMFS)

Program Goals:

The goals of the CDQ program are to provide eligible western Alaska villages with the opportunity to participate and invest in fisheries in the Bering Sea and Aleutian Islands Management Area (BSAI); to support economic development in western Alaska; to alleviate poverty and provide economic and social benefits for residents of western Alaska; and to achieve sustainable and diversified local economies in western Alaska.

Resource Provided:

A portion of the fishery quotas in the groundfish, halibut, and crab fisheries in the BSAI are allocated annually to the CDQ Program, under the Magnuson-Stevens Fishery Conservation and Management Act (a federal law). The CDQ allocations are made from fishery quotas in the BSAI and include 10% of the pollock quota, 10.7% of the quotas for selected other groundfish target species, 10% of most crab quotas, and between 20% and 100% of halibut quotas. In 2007, the CDQ entities held \$543 million in total assets and \$170 million in total revenues. Approximately 40% (or \$70 million) of the total revenues were derived from royalties paid to the CDQ entities for the CDQ fishery allocations.

Since inception of the CDQ Program in 1992, the CDQ entities have generated more than \$204 million in wages, education, and training benefits.

Eligibility:

Six CDQ non-profit managing organizations (CDQ entities) represent the 65 communities eligible for the CDQ Program.

They are:

- Aleutian Pribilof Island Community Development Association (APICDA)
- Bristol Bay Economic Development Corporation (BBEDC)
- Central Bering Sea Fishermen's Association (CBSFA)
- Coastal Villages Region Fund (CVRF)
- Norton Sound Economic Development Corporation (NSEDC)
- Yukon Delta Fisheries Development Association (YDFDA)

Wildlife Habitat Incentives Program (WHIP)

Administrative Agency:

Federal Agency: U.S. Department of Agriculture, Natural Resources Conservation Service (NRCS)

Program Goals:

The Wildlife Habitat Incentives Program (WHIP) is a voluntary program that encourages creation of high-quality wildlife habitats that support wildlife populations of national, state, tribal, and local significance.

Resource Provided:

Through WHIP, the NRCS provides technical and financial assistance to landowners and others to develop upland, wetland, riparian, and aquatic habitat areas on their property. WHIP can provide a financial cost-share incentive up to 75% of project costs. Other contributing partners may reduce the landowner's 25% portion.

Eligibility:

To be eligible, an entity must own or have control of the land that will be enrolled in the program for the duration of the agreement period. Eligible lands under the program are:

- Privately-owned land.
- Federal land where the primary benefit is on private or tribal land.
- State and local government land, on a limited basis.
- Tribal land.

Alaska Program Status:

Alaska's WHIP benefits include restoration and enhancement of critical salmon spawning, rearing, feeding, and escape cover, as well as Interior populations of whitefish and pike, which are crucial recreation and subsistence resources. WHIP provides low-impact approaches to restore fragmented moose and bear habitats, through the decommissioning or restoration of abused roads and trail areas. WHIP can help restore forest and woodland acres lost through spruce bark beetle and other forest destruction activities. Migratory birds and waterfowl heavily utilize WHIP shallow surface waters and surrounding area native plants. WHIP provides diverse ways for private citizens to become involved in wildlife conservation stewardship and to become educated and empowered in issues they see as important on their own property.

Youthbuild

Administrative Agency:

Federal Agency: U.S. Department of Labor (DOL)

Program Goals:

Youthbuild provides job training and educational opportunities for at-risk youth ages 16-24. They gain these skills while constructing or rehabilitating affordable housing for low-income or homeless families in their own neighborhoods. Youth split their time between the construction site and the classroom, where they earn their GED or high school diploma, learn to be community leaders, and prepare for college and other postsecondary training opportunities. Youthbuild includes significant support systems, such as a mentoring, follow-up education, employment, personal counseling services, and participation in community service and civic engagement.

Resource Provided:

DOL's Employment and Training Administration allows Youthbuild to provide grants on a competitive basis to non-profit organizations to assist high-risk youth between the ages of 16-24 to learn housing construction job skills and to complete their high school education. Program participants enhance their skills as they construct and/or rehabilitate affordable housing for low- and moderate-income persons.

Comments:

Application: After DOL publishes a Solicitation for Grant Applications (SGA) for the Youthbuild program, applicants must submit specific information about a proposed project in their application, including information on required match funds and the work-site description that demonstrates the availability of properties for building or rehabilitation. All grants deemed responsive to the SGA criteria are evaluated and selected based on a competitive panel review process.
