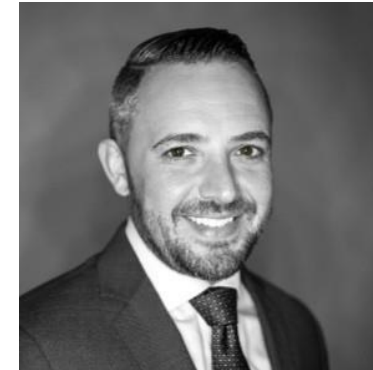

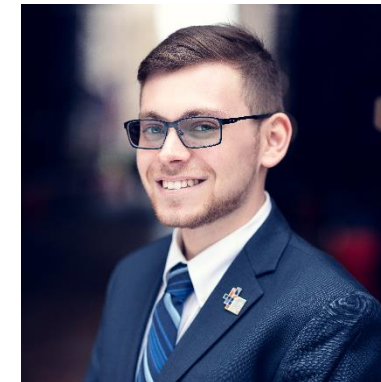

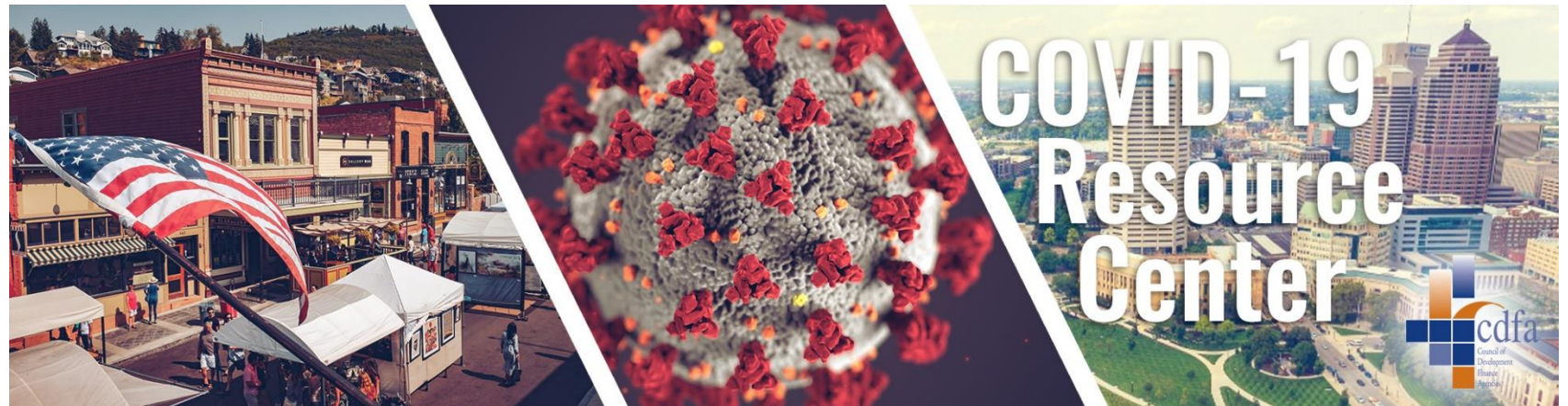

CARES Act

- \$2.2 Trillion
- SBA Economic Injury Disaster Loans
- Paycheck Protection Program
- Federal Agency Appropriations:
 - EDA: \$1.5 billion for economic development grants
 - MEP: \$50 million, plus cost match waived for FY2020
 - USDA Rural Development: \$145 billion; \$1 billion for B&I loan guarantee
 - HUD: \$17.4 billion; \$5 billion for CDBG
 - SBA: \$7 billion for disaster loans; \$562 million to administer disaster loans

- Overview of small business provisions thus far
- Small Business Access to Capital Act of 2020
 - Introduced as S. 3551 by Sens. Gary Peters (D-MI), Debbie Stabenow (D-MI), Jeanne Shaheen (D-NH), Maggie Hassan (D-NH)
 - Would provide \$3 billion to a reauthorized SSBCI Program
- Included in House mark-up of CARES Act as a \$10 billion program
