



FIGURE 1. GROWING SIGNIFICANCE OF MAINLAND CHINA AS A SOURCE OF EB-5 INVESTORS









## TOP COUNTRIES OF ORIGIN FOR EB-5 INVESTORS, PRE- AND POST-RECESSION

#### FIGURE 1A. I-526 APPROVALS BY INVESTOR'S COUNTRY ORIGIN OF BIRTH, FY1992-2008




#### FIGURE 1B. I-526 APPROVALS BY INVESTOR'S COUNTRY ORIGIN OF BIRTH, FY2009-2013








## Adjudication Trends: Approval Rates

- Avg. I-526 Approval Rate (FY2008-2014): 79.76%


I-526 Approval Rates Comparing to the Average Level (FY1992 - 2014, Q2)

I-829 Approval Rates Comparing to the Average Level (FY1992-2014, Q2)







## **Adjudication Trends: Processing Times**



On April 30th, the U.S. Citizenship and Immigration Services (USCIS) posted updated estimated average processing times for I-526, I-829 and I-924 petitions

I-829	6.0 Months	8.7 Months	
I-924	4.0 Months	4.4 Months
